



# Official Sweepstakes Rules

## 2022 AgFed CU Foundation Classroom Grant Sweepstakes Official Rules

**NO PURCHASE OR TRANSACTION OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS PROMOTION.**

**Contest Administrator and Period:** The \$100 AgFed CU Foundation Classroom Grant Sweepstakes (“Sweepstakes”) is being administered and operated by AgFed CU Foundation (“Foundation”). It begins at 12:00 AM EST on 08/15/2022 and ends at 11:59 PM EST on 08/31/2022 (“Promotion Period”).

**Eligibility:** The Sweepstakes is open to legal residents of the United States, 18 years or older as of the date of their entry. In order to win, the entrant must be currently employed as a teacher, a counselor, or a similar classroom-based position at a public or private school located within Washington DC, Maryland, or Virginia. The Foundation reserves the right to verify the eligibility of the winner. All federal, state and local regulations apply. **LIMIT ONE ENTRY PER PERSON.** The Contest is void outside of the United States and where prohibited by law. Foundation employees, officers, directors, committee members and members of their immediate families are not eligible to enter.

**How to enter:**

Entries must be received electronically via the AgFed CU Foundation Classroom Supply Grant form located at <https://www.agfedcufoundation.org/classroom-supply-grants/> by the end of the Promotion Period. Only one (1) entry per person.

**Prize:** There will be no more than ten (10) winners. Each winner will be awarded a \$100 check payable to them and sent to the school they are employed at to buy classroom materials. If a winner is disqualified, the Foundation reserves the right to conduct another drawing to determine an alternative winner or not to award that winner's prize, at its sole discretion. If a prize is unclaimed, the prize may be forfeited and awarded to an alternate winner.

**Drawing:** A random drawing will be conducted after August 31, 2022, and prior to September 5, 2022. Up to ten (10) winners will be selected from among all eligible entrants. Winners will be notified via email or by telephone and need not be present to win.

**Prize Conditions:** Winning a prize is contingent upon fulfilling all requirements set forth herein. **AN ENTRANT IS NOT A WINNER OF ANY PRIZE UNLESS AND UNTIL ENTRANT’S ELIGIBILITY HAS BEEN VERIFIED AND ENTRANT HAS BEEN NOTIFIED THAT VERIFICATION IS COMPLETE.** Odds of winning depend upon the number of eligible entrants.
